**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY
BRITT, IOWA, 2020, BY DELETING SECTION 6-5-9 AND SUBSTITUTING A
NEW SECTION 6-5-9 PERTAINING TO REFUSE COLLECTION RATES**

BE IT ENACTED by the City Council of the City of Britt, Iowa:

Section 1. The 2020 Code of Ordinances of the City of Britt, Iowa, is amended by deleting Section 6-5-9 and substituting the following:

6-5-9 REFUSE COLLECTION RATES

1. Residence Rate. For each resident with alley or curb pickup, monthly fees paid to the City shall be as follows:

a. Starting November 1st, 2024, the following refuse rates will be charged

Starting November 1st, 2024, and on the first day of each July thereafter, the refuse rates then in effect shall increase based on the chart above without further action by the City Council.

Rates increases are applicable to July rentals and are billed in August.

Section 2. Repealer Clause. Any Ordinance provision, or part thereof, which differs or is inconsistent with this Ordinance is hereby repealed to the extent of said difference or inconsistency.

Section 3. Severability. If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional by a Court of Competent Jurisdiction, such adjudication shall not affect the validity of the Ordinance as a whole, or any section provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. This Ordinance shall be in effect from and after its final passage, approval, posting and publication as required by law.
