AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY BRITT, IOWA, 2020, BY DELETING SECTION 6-5-10 AND SUBSTITUTING A NEW SECTION 6-5-10 PERTAINING TO RATE OF SEWER RENTAL AND MANNER OF PAYMENT.

BE IT ENACTED by the City Council of the City of Britt, Iowa:

Section 1. Code of Ordinances of the City of Britt, Iowa, is amended by deleting Section 6-5-10 and substituting the following:

6-5-10 RATE OF SEWER RENT AND MANNER OF PAYMENT.

A. The rate of sewer rent shall be in accordance with the schedule set forth below. The rent shall be paid with the water bill at the same time as payment of the water bill is due and under the same condition as to penalty for late payment, at the office of the City Administrator, beginning with the next payment after enactment of this ordinance, or, if connection has not been made, after the connection to the sewer system is made.

B. Sewer rental shall be as follows per residential property serviced:

Starting July 1st, 2025

C. Sewer rental shall be as follows per commercial/industrial property serviced:

Starting July 1, 2025

2031-2032	\$ 10.44	\$ 9.00

D. Sewer rates shall automatically increase according to the above charts on July 1st, 2025, and each July 1st thereafter.

Rates increases are applicable to July usage and are billed in August.

Section 2. Repealer Clause. Any Ordinance provision, or part thereof, which differs or is inconsistent with this Ordinance is hereby repealed to the extent of said difference or inconsistency.

Section 3. Severability. If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional by a Court of Competent Jurisdiction, such adjudication shall not affect the validity of the Ordinance as a whole, or any section provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. This Ordinance shall be in effect from and after its final passage, approval, posting and publication as required by law.
