

**ORDINANCE No. \_\_\_\_\_**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY BRITT, IOWA, 2020, BY DELETING SECTION 6-5-8 AND SUBSTITUTING A NEW SECTION 6-5-8 PERTAINING TO WATER RATES.**

BE IT ENACTED by the City Council of the City of Britt, Iowa:

Section 1. The 2020 Code of Ordinances of the City of Britt, Iowa, is amended by deleting Section 6-5-8 and substituting the following:

**6-5-8 WATER RATES.**

A. Water shall be furnished at the following rates per residential property serviced:

Starting July 1, 2025

Fiscal Year (July 1 <sup>st</sup> -June 30 <sup>th</sup> )	SERVICE CHARGE	Usage Change (per 1,000 Gallons)
2024-2025	\$ 22.56	\$ 12.52
2025-2026	\$ 23.24	\$ 12.90
2026-2027	\$ 23.94	\$ 13.29
2027-2028	\$ 24.66	\$ 13.69
2028-2029	\$ 25.40	\$ 14.10
2029-2030	\$ 26.16	\$ 14.52
2030-2031	\$ 26.94	\$ 14.96
2031-2032	\$ 27.75	\$ 15.41
2032-2033	\$ 28.58	\$ 15.87
2033-2034	\$ 29.44	\$ 16.35

Starting July 1, 2025, and on the first day of each July thereafter, the water rates then in effect shall increase based on the chart above without further action by the City Council.

B. Water shall be furnished at the following rates per commercial/ industrial property serviced:

Fiscal Year (July 1 <sup>st</sup> -June 30 <sup>th</sup> )	Service Charge	Usage Charge (per 1,000 Gallons)
2024-2025	\$ 26.78	\$ 13.39
2025-2026	\$ 27.58	\$ 13.79
2026-2027	\$ 28.41	\$ 14.20
2027-2028	\$ 29.26	\$ 14.63
2028-2029	\$ 30.14	\$ 15.07
2029-2030	\$ 31.04	\$ 15.52
2030-2031	\$ 31.96	\$ 15.99
2031-2032	\$ 32.92	\$ 16.47
2032-2033	\$ 33.91	\$ 16.96
2033-2034	\$ 34.93	\$ 17.47

Starting July 1, 2025, and on the first day of each July thereafter, the water rates then in effect shall increase based on the chart above without further action by the City Council.

Rates increases are applicable to July usage and are billed in August.

Section 2. Repealer Clause. Any Ordinance provision, or part thereof, which differs or is inconsistent with this Ordinance is hereby repealed to the extent of said difference or inconsistency.

Section 3. Severability. If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional by a Court of Competent Jurisdiction, such adjudication shall not affect the validity of the Ordinance as a whole, or any section provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. This Ordinance shall be in effect from and after its final passage, approval, posting and publication as required by law.
